STRATEGIC REPORT FOR THE 52 WEEKS ENDED 26 FEBRUARY 2022

The Directors present their Strategic Report of Tesco Corporate Treasury Services PLC (the “Company”) for the 52 weeks ended 26 February 2022 (prior period: 52 weeks ended 27 February 2021).

Instances of the “Group” make reference to Tesco PLC and its subsidiaries which includes the Company.

Business review and principal activity

The principal activity of the Company is to act as a financing company for certain Tesco Group subsidiaries, joint ventures and associates and also undertake activities to hedge the financial risks to the Group. The Company issues debt under medium term note programmes and provides funding to Tesco Group companies, joint ventures and associates.

There has been no significant change in the nature of this activity during the period and the Directors do not expect this to change significantly throughout the next financial period.

In October 2021, the Company issued £400,000,000 1.875% ESG Notes due 2028, guaranteed by Tesco PLC and issued under Tesco PLC’s, the Company’s and Tesco Corporate Treasury Services Europe DAC’s Euro Medium Term Note programme. This was the second sustainability-linked bond issuance linked to Tesco Group’s commitment to reduce greenhouse gas emissions. The launch of the second sustainability-linked bond demonstrates the strength of the commitment by the Tesco Group to reduce its impact on the environment by reaching its target of reducing GHG emissions by 60% by 2025 (against a 2015/16 baseline).

The level of hedge activity has decreased year on year as in the previous year the Company had entered into derivative contracts to hedge the external exposure as a result of the sale by the Tesco Group of its Asia business in the prior year. Details of the disposal are discussed on pages 138 to 139 of the Tesco PLC Annual Report and Financial Statements 2021, which does not form part of this Report.

Future outlook

The Company’s performance is expected to remain in line with the current period throughout the next financial period.

The Company’s future developments form a part of the Group’s long-term strategy, which is discussed on pages 14 and 15 to the Tesco PLC Annual Report and Financial Statements 2022, which does not form part of this Report.

Results and dividends

The results for the 52 weeks ended 26 February 2022 show a pre-tax profit of £7m (2021: pre-tax loss of £165m). Net assets increased to £914m (2021: £906m).

The Directors do not recommend payment of a dividend for the 52 weeks ended 26 February 2022 (2021: £500m).

Capital structure

Details of the authorised and issued share capital are shown in Note 15.

Key performance indicators (KPIs)

Given the straightforward nature of the business, the Directors are of the opinion that analysis using key performance indicators is not necessary for an understanding of the development, performance or position of the business.

Principal risks and uncertainties

Business risk

The Company's principal business relationships are with the Group which, by nature of their business, have continued to operate as essential businesses during the pandemic. This has served to mitigate some of the risk the Company is exposed to. At present, there is an increased level of macroeconomic uncertainty, which is beginning to show initial signs of impact on operational costs. This uncertainty has been exacerbated by the war in Ukraine. The Group is actively monitoring the situation and contingency measures are in place to manage these risks across the Group. As such, management believe that the short-term risks and impacts are understood and appropriate controls are in place. However, the long-term impacts remain uncertain and will continue to be monitored closely. The Group will continue to assess and monitor the potential risks and impacts on the Company and its stakeholders as a whole, while taking mitigation measures to address local challenges as appropriate.

Other risks and uncertainties are integrated with the principal risks of the Group which includes the Company. These are not managed separately and, accordingly, we refer to pages 31 to 37 of the Tesco PLC Annual Report and Financial Statements 2022, which does not form part of this Report.

Internal control and risk management systems

The Company acts as a financing company for certain Tesco PLC Group subsidiaries, joint ventures, and associates only, and therefore the internal control and risk management systems of the Company are aligned with those of the Group, which is discussed on pages 31 to 37 of the Tesco PLC Annual Report and Financial Statements 2022, which does not form part of this Report.

Funding and liquidity

The Company may finance its operations by using a combination of debt capital market issuances, commercial paper, intra-Group borrowings and bank borrowings. The objective is to ensure continuity of funding. The policy is to smooth the debt maturity profile and to arrange funding ahead of requirements.

Interest rate risk management

The Company's objective is to limit the impact to The Company's comprehensive income from rising interest rates. Forward rate agreements, interest rate swaps, caps and floors may be used to achieve the desired mix of fixed and floating rate debt.

Foreign currency risk management

The Company is exposed to foreign exchange risk principally via non-GBP inter-company loans to and from non-UK subsidiaries and Medium Term Notes (MTNs) issued in currencies other than GBP. Where appropriate these are hedged via foreign currency derivatives and borrowings in matching currencies. The former are not formally designated as hedges and gains and losses on hedged items and hedged loans will naturally offset. Whereas MTNs are formally designated hedges, where the Company enters derivatives with matching notional values.

Credit risk

The objective is to reduce the risk of loss arising from default by counterparties to financial transactions. The Company holds positions with an approved list of counterparties of good credit quality and these counterparties and their credit ratings are routinely monitored.

Section 172(1) Statement

Section 172 of the Companies Act 2006 requires a director of a company to act in the way he or she considers, in good faith, would most likely promote the success of the company for the benefit of its members as a whole. In doing this section 172 requires a director to have regard, amongst other matters, to the:

- likely consequences of any decisions in the long-term;
- interests of the company's employees;
- need to foster the company's business relationships with suppliers, customers and others;
- impact of the company's operations on the community and environment;
- desirability of the company maintaining a reputation for high standards of business conduct, and
- need to act fairly as between members of the company.

In discharging our section 172 duties the Directors have regard to the factors set out above. The Directors also have regard to other factors which we consider relevant to the decision being made. Those factors, for example, include the interests and views of members of the Tesco Group, Joint Venture Partners and associates, our relationship with our external lenders and investors, our relationship with the regulators and Tesco PLC as our shareholder and its relationship with rating agencies. We acknowledge that every decision we make will not necessarily result in a positive outcome for all of our stakeholders. By considering the Company's purpose, vision and values together with its strategic priorities and having a process in place for decision-making, we do, aim to make sure that our decisions are consistent and appropriate in all the circumstances.

We delegate authority for day-to-day management of the Company to senior management in setting, approving and overseeing execution of the business strategy and related policies. Board meetings are held periodically where the directors consider the Company's activities and make decisions. As a part of those meetings the Directors receive information in a range of different formats which includes information relevant to section 172 matters when making relevant decisions. For example, each year we make an assessment of the strength of the Company's balance sheet and future prospects relative to market uncertainties and make decisions about the payment of dividends.

The Company's key stakeholders are its colleagues, customers, suppliers and the shareholders. The Group's Code of Business Conduct defines the standards and behaviours expected of colleagues when interacting with our stakeholders. This is a fundamental part of the Company's culture and training which supports delivery of our Values and protects the reputation of the Company.

The views of and the impact of the Company's activities on those stakeholders are an important consideration for the directors when making relevant decisions. While there are cases where the Board itself judges that it should engage directly with certain stakeholder groups or on certain issues, the size and spread of both our stakeholders and Group means that generally our stakeholder engagement best takes place at an operational or group level. We find that as well as being a more efficient and effective approach, this also helps us achieve a greater positive impact on environmental, social and other issues than by working alone as an individual company. For details on some of the engagements that takes place with the Company's stakeholders so as to encourage the directors to understand the issues to which they must have regard please see page 20 to 21 of the Tesco PLC 2022 Annual Report.

During the period we received information to help us understand the interests and views of the Company's key stakeholders and other relevant factors when making decisions. This information was distributed in a range of different formats including in reports and presentations on our financial and operational performance, non-financial KPIs, risk, ESG matters and the outcomes of specific pieces of engagement. As a result of this we have had an overview of engagement with stakeholders and other relevant factors which allows us to understand the nature of the stakeholders' concerns and to comply with our section 172 duty to promote success of the Company.

INDEPENDENT AUDITOR’S REPORT TO THE MEMBERS OF TESCO CORPORATE TREASURY SERVICES PLC

Report on the audit of the financial statements

1. Opinion

In our opinion the financial statements of Tesco Corporate Treasury Services Plc (the ‘company’):

- give a true and fair view of the state of the company’s affairs as at 26 February 2022 and of its profit for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice, including Financial Reporting Standard 101 “Reduced Disclosure Framework”; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

We have audited the financial statements which comprise:

- the statement of comprehensive income;
- the balance sheet;
- the statement of changes in equity;
- the related notes 1 to 19.

The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 101 “Reduced Disclosure Framework” (United Kingdom Generally Accepted Accounting Practice).

2. Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the auditor’s responsibilities for the audit of the financial statements section of our report.

We are independent of the company in accordance with the ethical requirements that are relevant to our audit of the financial statements in the UK, including the Financial Reporting Council’s (the ‘FRC’) Ethical Standard as applied to listed public interest entities, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We confirm that we have not provided any non-audit services prohibited by the FRC’s Ethical Standard to the company.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

3. Summary of our audit approach

Materiality The materiality that we used in the current year was £27.2m which was determined on the basis of a percentage of the company's net assets.

Scoping Our audit was scoped based on our understanding of the company, its internal control, our risk assessment and our materiality.

Significant changes in our approach There have been no significant changes in our approach from the prior year.

4. Conclusions relating to going concern

In auditing the financial statements, we have concluded that the directors' use of the going concern basis of accounting in the preparation of the financial statements is appropriate.

Our evaluation of the directors' assessment of the company's ability to continue to adopt the going concern basis of accounting included:

- evaluating the role of the company within the Tesco Group and the intention of the Tesco Group to keep the company in existence;
- assessing the financial position of the Tesco Group as a whole at the reporting date;
- considering the company's year-end liquidity position, including an assessment of its levels of cash and short term investments compared with its current liabilities; and
- considering the financing facilities available to the company, including the ability to raise finance via its Medium-Term Note ('MTN') programme.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the company's ability to continue as a going concern for a period of at least twelve months from when the financial statements are authorised for issue.

Our responsibilities and the responsibilities of the directors with respect to going concern are described in the relevant sections of this report.

5. Key audit matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the financial statements of the current period and include the most significant assessed risks of material misstatement (whether or not due to fraud) that we identified. These matters included those which had the greatest effect on: the overall audit strategy, the allocation of resources in the audit; and directing the efforts of the engagement team.

These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

5.1. Potential for error or manipulation in calculating and recording the fair values of cross currency, interest rate and index-linked swaps

Key audit matter description

As at 26 February 2022, the collective net fair value of the company's cross currency, interest rate and index-linked swaps (the 'derivative financial instruments') was a liability of £143m (2021: liability of £59m). These derivative financial instruments comprise a mixture of trades entered into with external banks, as well as a number of internal, 'back-to-back' trades with other Tesco Group entities.

The derivative financial instruments are valued by calculating the net discounted future cash flows arising from each instrument (the 'fair value'), plus or minus credit risk and funding valuation adjustments (see section 5.2 below).

There is a risk that the fair values recorded in the company's accounting systems for the derivative financial instruments are not appropriate because:

- the inputs used by the company, such as forward rates, discount curves and cash flows, when valuing the trades using third party valuation tools are not appropriate; and/or
- the valuations produced using third party valuation tools do not reflect the contractual terms of the instruments themselves; and/or
- the methodology used when valuing the derivative financial instruments using third party valuation tools is not appropriately and consistently applied.

All of the above pose a risk which may result in income statement error.

Further details are included within the derivative financial instruments and hedge accounting section of Note 2 to the financial statements, as well as the critical judgements and estimates section of Note 2 and within the financial risk factors tables in Note 14.

How the scope of our audit responded to the key audit matter

We assessed the appropriateness of the methodology used by the company when valuing the derivative financial instruments.

We tested whether the fair values of the external and internal derivative trades are reasonable by selecting a sample of internal and external derivative trades and valuing these positions independently using third party tools, including Bloomberg, FastVal and Reval. These valuations were performed based on the terms of the trade contracts and market data (such as forward discount curves) obtained from these third-party tools. We compared our independent valuation against the valuations recorded in the general ledger and assessed the variances against risk-based thresholds we consider acceptable for the relevant types of instruments.

Key observations

Based on the procedures performed, we have concluded that the fair values of cross-currency, interest rate and index-linked swaps are reasonable.

5.2. Potential for error or manipulation in calculating and recording the credit, debit and funding valuation adjustments to the reported fair values of derivative financial instruments

Key audit matter description

The reported fair values of the company's derivative financial instruments (as described above) are adjusted to reflect default risk by recording a credit or debit valuation adjustment ('CVA/DVA') and funding valuation adjustment ('FVA'), with:

- CVA reflecting the default risk of the counterparty;
-

- DVA reflecting the company’s own risk of default; and
- FVA reflecting the estimated adjustment to the fair value that a market participant would make to account for funding costs they would incur in order to fund uncollateralised derivative financial instrument positions.

For derivative trades with parties external to the company, CVA/DVA are estimated by reference to observable, traded counterparty and Tesco Plc credit default swap (‘CDS’) spreads. For internal trades, the CVA/DVA is estimated by reference to Tesco Plc CDS spreads only (as the counterparty is another Tesco entity). The mismatch between the CVA/DVA on external and internal derivative instruments creates volatility in the Income Statement.

Management uses Bloomberg in order to estimate the CVA/DVA to be posted against cross currency swaps and interest rate swaps (which were in a liability position of £205m at the balance sheet date). Management use an Excel-based model populated with market data extracted from Bloomberg for index-linked swaps (which were in an asset position of £62m at the balance sheet date). FVA is calculated by using spreads derived by reference to bond prices relevant to the company’s market, which incorporate certain unobservable inputs. Therefore, there is an element of subjectivity in determining the spread used to estimate FVA. Further details are included within the derivative financial instruments and hedge accounting section of Note 2 to the financial statements, as well as the critical judgements and estimates section of Note 2.

How the scope of our audit responded to the key audit matter

We independently obtained credit and funding spreads using third-party sources of market data. For a sample of trades, we independently calculated the CVA/DVA and FVA using an independent model.

We compared the results of our independent CVA/DVA calculations to those recorded by management in the general ledger and assessed any resulting variances against thresholds we consider acceptable for the relevant types of instruments.

Regarding FVA, we performed the following procedures to evaluate the differences between (a) management’s funding spreads, which reflect the company’s assessment of the relevant market (being the company’s relationship banks), and (b) the spreads we calculated independently in consideration of the entire market:

- reviewed and assessed management’s method in defining the market for consistency with the principles of IFRS 13 “Fair Value Measurement”;
- assessed the data used by management for reasonableness against data obtained independently by us; and
- tested whether the average spread data had been calculated and applied correctly in line with management’s stated approach.

Key observations

Based on the procedures performed, we have concluded that the CVA/DVA and FVA recorded against the derivative financial instruments are reasonable.

6. Our application of materiality


6.1. Materiality

We define materiality as the magnitude of misstatement in the financial statements that makes it probable that the economic decisions of a reasonably knowledgeable person would be changed or

influenced. We use materiality both in planning the scope of our audit work and in evaluating the results of our work.

Based on our professional judgement, we determined materiality for the financial statements as a whole as follows:

Materiality	£27.2m (2021: £27m)
Basis for determining materiality	3% of net assets (2021: 3% of net assets).
Rationale for the benchmark applied	<p>The company acts as a financing company for other Tesco entities and its role is therefore to act as a treasury function, rather than to generate income.</p> <p>Consistent with the prior year, we concluded that the net assets of the company would be the most relevant benchmark for the users of the financial statements as this metric best reflects the overall financial strength and liquidity of the company and represents a more consistent metric upon which to base materiality in the longer term.</p>



6.2. Performance materiality

We set performance materiality at a level lower than materiality to reduce the probability that, in aggregate, uncorrected and undetected misstatements exceed the materiality for the financial statements as a whole. Performance materiality was set at 70% of materiality for the 2022 audit (2021: 70%). In determining performance materiality, we considered the following factors:

- our risk assessment, where we concluded that the number of risks which we have classified as having a higher or significant risk of material misstatement was not disproportionately high compared to the overall number of risks identified; and
- the company’s business operations, transaction processes and control environment, which have remained consistent compared with the previous year.

6.3. Error reporting threshold

We agreed with those charged with governance that we would report to them all audit differences in excess of £1.36m (2021: £1.35m), as well as differences below that threshold that, in our view, warranted reporting on qualitative grounds. We also report to those charged with governance on

disclosure matters that we identified when assessing the overall presentation of the financial statements.

7. An overview of the scope of our audit

Our audit scope is based on our understanding of the company and its internal control, our risk assessment and our materiality. Audit work to respond to the risks of material misstatement was performed directly by the audit engagement team.

8. Other information

The other information comprises the information included in the annual report, other than the financial statements and our auditor's report thereon. The directors are responsible for the other information contained within the annual report.

Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon. Our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the course of the audit, or otherwise appears to be materially misstated.

If we identify such material inconsistencies or apparent material misstatements, we are required to determine whether this gives rise to a material misstatement in the financial statements themselves. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

9. Responsibilities of directors

As explained more fully in the directors' responsibilities statement, the directors are responsible for the preparation of the financial statements and for being satisfied that they give a true and fair view, and for such internal control as the directors determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the directors are responsible for assessing the company's ability to continue as a going concern, disclosing as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the company or to cease operations, or have no realistic alternative but to do so.

10. Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

A further description of our responsibilities for the audit of the financial statements is located on the FRC's website at: www.frc.org.uk/auditorsresponsibilities. This description forms part of our auditor's report.

11. Extent to which the audit was considered capable of detecting irregularities, including fraud

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below.

11.1. Identifying and assessing potential risks related to irregularities

In identifying and assessing risks of material misstatement in respect of irregularities, including fraud and non-compliance with laws and regulations, we considered the following:

- the nature of the industry and sector, control environment and business performance including the design of the company's remuneration policies, key drivers for directors' remuneration, bonus levels and performance targets;
- results of our enquiries of management and those charged with governance about their own identification and assessment of the risks of irregularities;
- any matters we identified having obtained and reviewed the company's documentation of their policies and procedures relating to:
 - identifying, evaluating and complying with laws and regulations and whether they were aware of any instances of non-compliance;
 - detecting and responding to the risks of fraud and whether they have knowledge of any actual, suspected or alleged fraud;
 - the internal controls established to mitigate risks of fraud or non-compliance with laws and regulations;
- the matters discussed among the audit engagement team and relevant internal specialists, including financial instrument specialists regarding how and where fraud might occur in the financial statements and any potential indicators of fraud.

As a result of these procedures, we considered the opportunities and incentives that may exist within the organisation for fraud. In common with all audits under ISAs (UK), we are also required to perform specific procedures to respond to the risk of management override.

We also obtained an understanding of the legal and regulatory framework that the company operates in, focusing on provisions of those laws and regulations that had a direct effect on the determination of material amounts and disclosures in the financial statements. The key laws and regulations we considered in this context included the UK Companies Act and the Listing Rules.

In addition, we considered provisions of other laws and regulations that do not have a direct effect on the financial statements but compliance with which may be fundamental to the company's ability to operate or to avoid a material penalty.

11.2. Audit response to risks identified

As a result of performing the above, we did not identify any key audit matters related to the potential risk of fraud or non-compliance with laws and regulations. Our procedures to respond to risks identified included the following:

- reviewing the financial statement disclosures and testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described as having a direct effect on the financial statements;
- enquiring of management and those charged with governance concerning actual and potential litigation and claims;

- performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatement due to fraud;
- reading minutes of meetings of those charged with governance; and
- in addressing the risk of fraud through management override of controls, testing the appropriateness of journal entries and other adjustments; assessing whether the judgements made in making accounting estimates are indicative of a potential bias; and evaluating the business rationale of any significant transactions that are unusual or outside the normal course of business.

We also communicated relevant identified laws and regulations and potential fraud risks to all engagement team members including internal specialists and remained alert to any indications of fraud or non-compliance with laws and regulations throughout the audit.

Report on other legal and regulatory requirements

12. Opinions on other matters prescribed by the Companies Act 2006

In our opinion, based on the work undertaken in the course of the audit:

- the information given in the strategic report and the directors' report for the financial year for which the financial statements are prepared is consistent with the financial statements; and
- the strategic report and the directors' report have been prepared in accordance with applicable legal requirements.

In the light of the knowledge and understanding of the company and its environment obtained in the course of the audit, we have not identified any material misstatements in the strategic report or the directors' report.

13. Matters on which we are required to report by exception

13.1. Adequacy of explanations received and accounting records

Under the Companies Act 2006 we are required to report to you if, in our opinion:

- we have not received all the information and explanations we require for our audit; or
- adequate accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us; or
- the financial statements are not in agreement with the accounting records and returns.

We have nothing to report in respect of these matters.

13.2. Directors' remuneration

Under the Companies Act 2006 we are also required to report if in our opinion certain disclosures of directors' remuneration have not been made.

We have nothing to report in respect of this matter.

14. Other matters which we are required to address

14.1. Auditor tenure

Following the recommendation of those charged with governance, we were appointed by the Group's shareholders on 26 June 2015 to audit the financial statements for the 52 weeks ending 27 February

2016 and subsequent financial periods. The period of total uninterrupted engagement including previous renewals and reappointments of the firm is 7 periods of 52 or 53 weeks each, covering the periods ending 27 February 2016 to 26 February 2022.

14.2. Consistency of the audit report with the additional report to the audit committee

Our audit opinion is consistent with the additional report to the audit committee we are required to provide in accordance with ISAs (UK).

15. Use of our report

This report is made solely to the company's members, as a body, in accordance with Chapter 3 of Part 16 of the Companies Act 2006. Our audit work has been undertaken so that we might state to the company's members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the company and the company's members as a body, for our audit work, for this report, or for the opinions we have formed.

NOTES TO THE FINANCIAL STATEMENTS FOR THE 52 WEEKS ENDED 26 FEBRUARY 2022

1. AUTHORISATION OF FINANCIAL STATEMENTS AND STATEMENT OF COMPLIANCE WITH FRS 101

The financial statements of Tesco Corporate Treasury Services PLC (the “Company”) for the 52 weeks ended 26 February 2022 were approved by the Board of Directors on 19th August 2022 and the balance sheet was signed on the Board’s behalf by Lynda Heywood. Tesco Corporate Treasury Services PLC is a public limited company and is incorporated and domiciled in the United Kingdom and registered in England and Wales.

These financial statements were prepared in accordance with Financial Reporting Standard 101 “Reduced Disclosure Framework” (FRS 101). The financial statements have been prepared under the historical cost convention and the Companies Act 2006 as modified by the fair value measurement of derivatives.

2. ACCOUNTING POLICIES

General information and Basis of preparation

Tesco Corporate Treasury Services PLC is a company limited by shares incorporated in the United Kingdom under the Companies Act 2006. The address of the registered office is given on page 6. The nature of the Company’s operations and its principal activities are set out in the Strategic Report on pages 2 to 6.

These financial statements have been prepared in accordance with Financial Reporting Standard 101, Reduced Disclosure Framework (“FRS 101”) and the Companies Act 2006 (the “Act”).

The Directors have, at the time of approving the financial statements, a reasonable expectation that the Company has adequate resources to continue in operational existence for a period of at least twelve months and therefore continued to adopt the going concern basis in preparing the annual financial statements.

In preparing these financial statements, the Company applies the recognition, measurement and disclosure requirements of International Financial Reporting Standards as adopted for use within the UK (“Adopted IFRSs”), but makes amendments where necessary in order to comply with Companies Act 2006 and has set out below where advantage of the FRS 101 disclosure exemptions has been taken. Following the UK’s exit from the European Union the Company has early adopted the FRS 101 amendments ‘UK exit from the European Union’.

The Company is a qualifying entity for the purposes of FRS 101. Note 17 gives details of the Company’s parent and from where its consolidated financial statements prepared in accordance with IFRS may be obtained.

The disclosure exemptions adopted by the Company in accordance with FRS 101 are as follows:

- The requirements of paragraphs 10(d), 10(f), 39(c) of IAS 1 Presentation of Financial Statements;
- The requirements of IAS 7 Statement of Cash Flows;
- The requirements of paragraphs 30 and 31 of IAS 8 Accounting Policies, Changes in Accounting Estimates and Errors; and
- The requirements in IAS 24 Related Party Disclosures to disclose related party transactions entered into between two or more members of a group, provided that any subsidiary which is a party to the transaction is wholly owned by such a member.

The Company is a financial institution for the purposes of FRS 101 and therefore may not take advantage of the exemptions from IFRS 7 Financial Instruments: Disclosures, paragraphs 91 to 99 of IFRS 13 Fair Value Measurement, and paragraphs 134 to 136 of IAS 1 Presentation of Financial Statements.

The following standard amendments were adopted in the prior financial year and further details of their impact on the financial statements are given in Note 14.

- ‘Interest rate benchmark reform Phase 2’ amendments to IFRS 9 – Financial Instruments and IFRS 7 – Financial Instruments – Disclosures, which have been adopted early.

Critical accounting judgements and key sources of estimation uncertainty

In the application of the Company's accounting policies the directors are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The directors consider there to be critical judgements in

- a) Determining the carrying value of derivative financial instruments which requires assumptions to be made about their future cash flows and has therefore been considered to be a key accounting estimate. Further information on these instruments and how they are valued is contained in Notes 13 and 14.
- b) determining the carry value of derivative financial instruments in relation to X-valuation adjustments (XVA). These are largely in relation the Funding valuation adjustments (FVA), which require assumptions and estimates in relation to the funding costs of counterparty financial institutions.

Impairment of financial assets

The Company assesses on a forward-looking basis the expected credit losses (ECLs) associated with its financial assets carried at amortised cost. The ECLs are updated at each reporting date to reflect changes in credit risk. The three-stage model for impairment has been applied to loan receivables from joint ventures and group undertakings. The credit risk is determined through modelling a range of possible outcomes for different loss scenarios, using reasonable and supportable information about past events, current conditions and forecasts of future events and economic conditions and taking into account the time value of money. A 12-month ECL is recognised, unless the credit risk on a financial asset increases significantly after initial recognition, when lifetime ECLs are recognised.

Foreign currencies

The Company's financial statements are presented in sterling, which is also the Company's functional currency, as this is an extension of the UK based parent company for which the functional currency is sterling.

Transactions in foreign currencies are translated into pounds sterling at the exchange rate on the date of the transaction. At each Balance Sheet date, monetary assets and liabilities that are denominated in foreign currencies are retranslated into pounds sterling at the exchange rates prevailing at the balance sheet date. All foreign exchange differences are taken to the Statement of Comprehensive Income for the period.

Financial instruments

Financial assets and financial liabilities are recognised on the Balance Sheet when the Company becomes a party to the contractual provisions of the instrument.

Receivables

Receivables are recognised initially at fair value, and subsequently at amortised cost using the effective interest rate method, less provision for impairment.

Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that gives a residual interest in the assets of the Company after deducting all of its liabilities. Equity instruments issued by the Company are recorded as the proceeds received, net of direct issue costs.

Borrowings

Interest-bearing borrowings and overdrafts are initially recorded at fair value, net of attributable transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost with any differences between cost and redemption value being recognised in the Statement of Comprehensive Income over the period of the borrowings on an effective interest basis.

Other payables

Other payables are recognised initially at fair value, and subsequently at amortised cost using the effective interest rate method.

Derivative financial instruments and hedge accounting

The Company uses derivative financial instruments to hedge its own and the Group's exposure to foreign exchange and interest rate risks arising from operating, financing and investing activities. The Company does not hold or issue derivative financial instruments for trading purposes; however, if derivatives do not qualify for hedge accounting they are accounted for as fair value through profit and loss (FVTPL).

Derivative financial instruments are recognised and stated at fair value. Where derivatives do not qualify for hedge accounting, any gains or losses on re-measurement are immediately recognised in the Statement of Comprehensive Income. Where derivatives qualify for hedge accounting, recognition of any resultant gain or loss depends on the nature of the hedge relationship and the items being hedged.

In order to qualify for hedge accounting, the Company is required to document from inception, the relationship between the item being hedged and the hedging instrument. The Company is also required to document and demonstrate an assessment of the relationship between the hedged item and the hedging instrument, which shows that the hedge will be highly effective on an on-going basis. This effectiveness testing is performed at each reporting date to ensure that the hedge remains highly effective.

Derivative financial instruments with maturity dates of more than one year from the balance sheet date are disclosed as non-current.

Interest income

Interest income is recognised when it is probable that the economic benefits will flow to the Company and the amount of revenue can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Cash flow hedging

Derivative financial instruments are classified as cash flow hedges when they hedge the Company's exposure to variability in cash flows that are either attributable to a particular risk associated with a recognised asset or liability, or a highly probable forecasted transaction. The effective element of any gain or loss from re-measuring the derivative instrument is recognised directly in equity.

The associated cumulative gain or loss is removed from equity and recognised in the Statement of Comprehensive Income in the same period during which the hedged transaction affects the Statement of Comprehensive Income. The classification of the effective portion when recognised in the Statement of Comprehensive Income is the same as the classification of the hedged transaction. Any element of the re-measurement criteria of the derivative instrument which does not meet the criteria for an effective hedge is recognised immediately in the Statement of Comprehensive Income.

Hedge accounting is discontinued when the hedging instrument expires or is sold, terminated or exercised, or no longer qualifies for hedge accounting or is de-designated. At that point in time, any cumulative gain or loss on the hedging instrument recognised in equity is retained in equity until the forecasted transaction occurs or the original hedged item affects the Statement of Comprehensive Income. If a forecasted hedged transaction is no longer expected to occur, the net cumulative gain or loss recognised in equity is transferred to the Statement of Comprehensive Income.

Fair value hedging

Derivative financial instruments are classified as fair value hedges when they hedge the Company's exposure to changes in the fair value of a recognised asset or liability. Changes in the fair value of derivatives that are designated and qualify as fair value hedges are recorded in the Company's income statement, together with any changes in the fair value of the hedged item that is attributable to the hedged risk.

Current taxation

Current tax, including UK corporation tax and foreign tax, is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date. The tax currently payable is based on taxable profit for the period. Taxable profit differs from net profit as reported in the income statement because it excludes items of income or expense that are taxable or deductible in other periods and it further excludes items that are never taxable or deductible.

Group relief on taxation

The Company may receive or surrender group relief from group companies without payment and consequently there may be no tax charge in the Statement of Comprehensive Income.

Deferred tax

Deferred tax is the tax expected to be payable or recoverable on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit, and is accounted for using the balance sheet liability method. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, and interests in joint ventures, except where the Company is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future. The carrying amount of deferred tax assets is reviewed at each Balance Sheet date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the assets to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised based on tax laws and rates that have been enacted or substantively enacted at the balance sheet date. Deferred tax is charged or credited to the income statement, except when it relates to items charged or credited in other comprehensive income or other equity, in which case deferred tax is also dealt with in other comprehensive income or other equity.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the company expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Company intends to settle its current tax assets and liabilities on a net basis.

Liquidity risk

Liquidity risk arises from the maturity profile associated with the borrowings in issuance. Foreign exchange risk

The Company is exposed to foreign exchange risk via non-GBP inter-company loans to and from non-UK Group subsidiaries. Where appropriate these are hedged via foreign currency derivatives and borrowings in matching currencies. These are not formally designated as hedges and gains and losses on hedges and hedged loans will naturally offset.

In addition foreign exchange risk arises from borrowings issued in currencies other than sterling. To mitigate this risk the Company enters derivatives with matching notional values or lending to other Group subsidiaries in matching currency where appropriate.

Market rate risk

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises of three risk: interest rate risk, currency risk and other price risk, such as equity price risk and commodity risk. Financial instruments affected by market risk include loans and borrowings and investments.

Capital risk

The Company's objectives when managing capital risk (defined as net debt plus equity) are aligned to those of the Tesco Group. These are outlined in the Tesco PLC Annual Report and Financial Statements 2022.

For the purpose of the Company's capital management, capital includes issued ordinary shares and other equity reserves attributable to the equity shareholders of the parent. The primary objective of the Company's capital management is to maximise the shareholder value.

The Company manages its capital structure and makes adjustments in light of changes in economic conditions and the requirements of any financial covenants. To maintain or adjust the capital structure, the company may adjust the dividend payment to shareholders, return capital or issue new shares.

No changes were made in the objectives, policies or processes for managing capital during the 52 weeks ended 26 February 2022 and 52 weeks ended 27 February 2021.

Business risk

The Company is, by virtue of its lending to other Group and related party entities, especially Tesco Group operating subsidiaries around the world, exposed to the impact of the pandemic. The Tesco Group operating subsidiaries have continued to operate during the pandemic and as such reduce the risk to the Company. In the event of a prolonged downturn as a result of the pandemic and Government's responses, Group companies and related parties borrowing from the Company may be unable to make interest and/or principal repayments when they are due.

In order to mitigate this risk the Company has access to capital markets which allow access to new funds, which in turn would be used to make interest and capital repayments on existing debt.

The wider Tesco Group including the Company continues to assess, monitor and where possible mitigate the risks and impacts of the pandemic upon the Company and its stakeholders.

IBOR reform

The Company early adopted the ‘Interest rate benchmark reform’ amendments Phase 2 to IFRS 9 in the prior year. During the year, the Company transitioned to alternative benchmark rates for all remaining hedging instruments, implementing the relevant risk-free rate benchmarks into its ISDAs and other relevant agreements. As at 26 February 2022, there were no hedging relationships which include IBOR benchmarks and are yet to be transitioned to a risk-free rate benchmark.
